**NOTICE OF PUBLIC HEARING**  
**Notice to Citizens of Richmond, Virginia**

As directed by the U.S. Department of Housing and Urban Development (HUD), the Richmond Redevelopment and Housing Authority (RRHA) has formulated its plans for the use of the **Fiscal Year 2009 Public Housing Capital Fund Grant being provided in accordance with the American Recovery and Reinvestment Act of 2009** (“the Recovery Act”). This grant of \$10,764,797 is separate from and in addition to the normal Capital Fund Grant received by RRHA from HUD on an annual basis.

A copy of the RRHA plan for use of funds provided under the 2009 Recovery Act Capital Grant is available for public examination, as prescribed by HUD, for the ten (10) calendar day period beginning March 30, 2009 and ending April 8, 2009 at RRHA’s main office located at 901 Chamberlayne Parkway, Richmond, Virginia 23220, during the business hours of 8:30 a.m. to 5:00 p.m., Monday through Friday.
